Clinical practice;

Every year, about 1,000 gastric cancer surgery at the Division of Gastrointestinal Surgery, Seoul National University Hospital (SNUH) with about 20% morbidity and <0.5% mortality (0% in year 2015). Usually I perform 8 cases of gastric cancer surgery including 5 laparoscopic gastric surgery per week and one robot-assisted gastrectomy.

Through a multidisciplinary case conference for selected gastric cancer patients who need clinical decision as well as scientific interest, surgeons, gastroenterologists, medical oncologists, radiologists, nuclear medicine doctor and pathologists discuss on selected cases for treatment plan. This conference has been very helpful not only for patient treatment decision but also for clinical trials. Since December 2012, this gastric cancer conference was shared with MGH, Boston through teleconference every three months.

We have a database of over 20,000 gastric cancer patients collected for the last 20 years at SNUH. Dr. Sano from Japan and I were invited to the UICC-AJCC TNM classification committee held in August, 2008 at Roswell Park Cancer Institute. My proposal of classification using SNUH database survival data and Dr. Sano's proposal using Cancer Research Institute's database contributed very much to the committee's decision for the 7th edition of TNM staging classification of gastric cancer. This has been published in the journal (Ahn HS, Hahn S, **Yang HK (Corresponding author)**, Evaluation of the Seventh American Joint Committee on Cancer/International Union Against Cancer Classification of gastric adenocarcinoma in comparison with the sixth classification. Cancer. 2011)

Education activities:

I give lectures to medical students.

We also have one or two international elective students from abroad (Germany, USA, Australia etc). Last year, we had two from Univ. of Sao Paolo, Brazil and one from Hamburg Univ.

We train 16-18 residents per grade at the department of Surgery, Seoul National University Hospital.

Each year, I have two or three fellows at Division of Gastrointestinal Surgery. I train them to perform gastric cancer surgery and research ready for independent gastric cancer treatment team leader, to be involved not only in clinical trials but also in some translational researches. My fellows got faculty positions at university teaching hospitals (Seoul National University Hospital, Kyung-Sang National University Hospital etc.) with gastric cancer specialty.

In 2008, I had ten visiting surgeons (at least for one week) from abroad for observation. A staff surgeon from Singapore stayed for one year to learn gastric cancer surgery. His visit was supported by Singapore government. I also had visiting surgeons from Nepal (for two months), from Japan, Germany, United States and Chile. Especially, Roswell Park Cancer Institute, Buffalo, USA sent their surgical Oncology fellows for one month elective visit to my division for gastric cancer surgery experience. We had 7 fellows from RPCI so far. Nowadays, we have 20-40 international visitors for observation and we had about 200 oversea visiting doctors since 2008 (from Japan, USA, Germany, UK, Italy, Kazakhstan, Israel and so on).

Since 2006, I have organized a surgical skill workshop with a few surgeons from other university. This workshop provides not only basic surgical skill training opportunity to trainees but also opportunity to see how different surgical skills are among surgeons. This training group became the first official study group of Korean Surgical Society and now our training programs became as mandatory programs for resident for their board examination. This program includes not only basic suture course as well as ultrasonography, gastroscopy, colonoscopy and laparoscopic skill courses. We encourage young university surgeons to join as tutors and provide them tutor workshop to share their ideas and experience among different subspecialties.

In 2004, I have started Korean Laparoscopic Gastrointestinal Surgery Study Group with leading Korean surgeons, which provides educational conference as well as animal workshop. I was the founding chairman for this KLASS. KLASS has been conducting critical multicenter trials (KLASS 01, 02, 03, 04, 05).

I have hosted animal workshops for laparoscopic gastric surgery at Seoul National University Hospital since 2000. This study group devoted to the development of laparoscopic surgery for gastric cancer in KOREA. I also started Japan-Korea Joint Seminar on laparoscopic surgery with Professor Kitano at Oita University since 2006. This seminar provided not only podium for exchange experience but also for collaboration between two countries for laparoscopic gastric cancer surgery. With leading Korean and Japanese surgeons, Professor Kitano and I published an English textbook for laparoscopic gastrectomy for cancer (publisher; Springer). This

Research activities;

I have my research laboratory at Cancer Research Institute, Seoul National University (in the same campus of Seoul National University Hospital). I currently supervise two PhD-course students. We have a research meeting once every week with graduate students, fellows and clinical coordinator.

Current research topics;

- 1) Genomic data driven personalized medicine using PDX (government funded project): a PI for gastric cancer
- 2) Local drug delivery using hydrogel; Hydrogel is in fluid status at room temperature but becomes gel at body temperature. We inoculate this hydrogel mixed with chemotherapeutic agent results in local delivery of high concentration of chemotherapeutic agent to the tumor site but without systemic toxicity. This study is in collaboration with Korean Institute of Science and Technology. Research grant is from the government grant for the next generation project about US\$200,000 per year since 2004 (the amount is as of 2008 currency rate)
- 3) microRNA; We have explored microRNAs expressed abnormally in gastric cancer tissues by microarray. We are in process of identifying the biological function of microRNA. This study is in collaboration with Narry Kim at School of Biological Science, Seoul National University. Research grant from the government grant for cancer research; US\$40,000 per year for 3 years since 2007.
